The test report needs to be in English or Danish. 所有到达或在哥本哈根机场转机的旅客必须提供来自第一乘机点的出发前 48 小时以内的核酸阴性检测报告。检测报告须为英文或丹麦文。

- Upon arrival at Copenhagen Airport passengers are required to obtain two Covid-19 tests (PCR and IgM Antibody test) again. The negative test certificate needs to be validated by the Chinese embassy in Denmark to receive a:
 - HS code (Chinese Citizens) or
 - HDC code (Non-Chinese citizens)

Currently, it takes about 6 hours to complete the tests and obtain the QR code
